RELEASING SEIZED PROPERTY PROCEDURE

The following procedures must be adhered to when officers are releasing seized property to its lawful owner:

- 1. The primary officer must return seized property to the lawful owner when:
 - · No one is disputing the ownership of the seized property; and
 - The seized property is not expected to be required for any court proceedings.
- 2. The primary officer will obtain approval from their supervisor before releasing any of the following:
 - · Any item seized under a search warrant
 - An item that is illegal to possess
 - · An item that contains illegal content
 - Cash
 - Any weapon
 - Any item seized for forensic analysis
- 3. The primary officer will ask the recipient to provide photo identification.
- 4. The officer will confirm the recipient's identification matches the lawful owner identified in the property records.
- 5. The officer will record the transaction in the property records.
- 6. The recipient must sign the release form to receive the property.
- 7. The officer will photograph the property with the recipient to confirm the item has been returned.

Section 1: Enter today's date (year first, followed by the month, and the day last).

Section 2: Record the witness's name (last name first, followed by the full first name, then middle initial if available).

Section 3: Select ONE of the Witness Type options listed.

Section 4: Record the witness's phone number, including area code.

Section 5: Record the witness's home address. Include an apartment number where applicable.

Section 6: Witness should provide a detailed description of what they observed. Ensure the statement is clear and complete.

Section 7: Record where the collision occurred, including either the intersection, or the street along which the collision occurred and the nearest intersection.

Section 8: Record the date of the collision (year first, followed by the month, and the day last).

Section 9: Record the time of the collision in the 24-hour clock format (e.g., three o'clock in the afternoon shall be entered as 1500 hours).

Section 10: Record the names and regimental numbers of the officer(s) who investigated the collision.
