## I DNA WARRANT PROCEDURE I

The following procedures must be adhered to when officers are applying for and executing a DNA Warrant:

- 1. Officer will include reasonable grounds to believe the following:
  - That an offence has been committed
  - That a bodily substance has been found in the place where the offence was committed
  - That the person was a party to the offence
  - That forensic DNA from the person will provide evidence about whether the bodily substance at the crime scene was from the person.
- 2. Officer will arrange for a qualified CPS member to attend and obtain the sample of bodily substances.
- 3. Officer will ensure the DNA warrant is completed and reviewed by their supervisor.
- 4. The supervisor will review the warrant, and, if approved, assign the warrant an identification number.
- 5. The officer will submit the DNA warrant to a Justice of the Alberta Court of Justice for approval.
- 6. Upon receiving the justice's approval of the DNA warrant, officers will obtain a sample collection kit.
- 7. Officer will advise the named person they are detained for the purpose of obtaining a bodily sample under the warrant and must accompany you for that purpose.
- 8. Read the person their Charter rights prior to the sample collection and facilitate any request to contact a lawyer.
- 9. While obtaining the sample of the bodily substance, ensure the privacy of the person as much as possible. Give the person repeated opportunities to voluntarily comply, and use only as much force as necessary if required.
- 10. Ensure the sample is properly packaged, and deliver it to the Evidence & Property Team.

**Section 5:** Record the respondent's last known home address. Include an apartment or unit number where applicable.

**Section 6:** Record the names of any children involved (last name first, followed by the first name, then the middle initial if available), the name of the person with whom they live, and the child's date of birth (year first, followed by the month, and the day last).

**Section 7:** Record the type(s) of family violence that have occurred.

**Section 8:** Record the claimant's home address and the distance the respondent is required to maintain from it.

**Section 9:** Record the names of the first and last names of the persons the respondent shall not communicate with or contact.

**Section 10:** Record the name and regimental numbers of the officer(s) who served the Emergency Order to the respondent.
